









The Basic Law of the Macao Special Administrative Region of the People's Republic of China 1999

Article 1 "The Macao Special Administrative Region is an inalienable part of the People's Republic of China."

Article 2 "The National People's Congress authorizes the Macao Special Administrative Region to exercise a high degree of autonomy and enjoy executive, legislative and independent judicial power, including that of final adjudication, in accordance with the provisions of this Law." <u>Text</u>
